Facilities offered:

- Free boarding and lodging. 20-bed capacity
- Round the clock staff and RMOs
- Renowned doctors available
- Free chemotherapy and radiotherapy (when the patient is young and the prognosis are good)
- Free blood tests
- Procedures of nerve blocks performed for pain management
- In-house pharmacy with free medicines
- Physiotherapy
- Counseling by renowned psychologists

- Lodging and kitchen facilities for attendants.

All the above mentioned services are very expensive and need considerable amount of funds. We do receive donations from philanthropists organizations and concerned citizens but there is an urgent need for some regular source of income to ensure the efficient continuity of our services.
